

AffiliateIT Website Privacy Policy

This Privacy Policy (hereinafter referred to as the "Policy") applies to all information that AffiliateIT (hereinafter referred to as AffiliateIT, we) and/or its affiliates, including all persons in the same group with AffiliateIT, may receive about the user during the time of using the site <http://affiliateit.com> (hereinafter referred to as the site), and the services that are presented on the site (hereinafter referred to as the Services).

The use of the Services and the site means the user's unconditional consent to this Policy and the conditions for processing his personal information specified therein; in case of disagreement with these conditions, the user must refrain from using the Services and the site.

Personal information of users received and processed by AffiliateIT

For the purposes of this Policy, "User's personal information" means:

Personal information that the user provides about himself on his own when registering (creating an account) or in the process of using the Services, including the user's personal data. Mandatory for the provision of the Services (rendering of services) information is marked in a special way. Other information is provided by the user at his discretion.

Data that is automatically transmitted to the Services and the site in the process of using them using the software installed on the user's device, including IP address, cookie information, information about the user's browser (or other program that accesses the Services), access time, address of the requested page.

Other information about the user, if its collection and / or provision is defined in the regulatory documents of individual Services.

This Policy applies only to the Services presented on the site. AffiliateIT does not control and is not responsible for third party websites to which the user may follow the links available on the website. AffiliateIT generally does not verify the accuracy of personal information provided by users and does not exercise control over their legal capacity. However, we assume that the user provides reliable and sufficient personal information on the questions offered in the registration form, and keeps this information up to date. The risk of providing false information is borne by the user who provided it.

Purposes of collecting and processing personal information of users

AffiliateIT collects and stores only those personal data that are necessary for the provision of the Services and the correct operation of the site. We may use the user's personal information for the following purposes:

To communicate with the user, including sending notifications, requests and information regarding the use of the Services, the provision of services, as well as processing requests and applications from the user;

Improving the quality of the Services and the site, the convenience of their use, the development of new Services and services;

Targeting advertising materials;

Conducting statistical and other research based on depersonalized data.

Conditions for processing the user's personal information and its transfer to third parties

AffiliateIT may transfer the user's personal information to third parties only in the following cases:

The user has expressed his consent to such actions;

The transfer is necessary as part of the user's use of a particular Service or to provide a service to the user;

The transfer is provided for by Russian or other applicable legislation within the framework of the procedure established by law;

When processing personal data of users, AffiliateIT is guided by the legislation on the protection of personal data.

Change by the user of personal information

The user can at any time change (update, supplement) or delete the personal information provided by him or part of it, as well as the parameters of its confidentiality, using the function of editing personal data in the personal account of the site section "Personal account".

Minors

We will not knowingly collect, use or disclose personal information from anyone under the age of 18 without obtaining prior consent from those who have parental responsibility for such users (for example, parents or guardians) through direct offline contact.

Measures taken to protect users' personal information

AffiliateIT takes the necessary and sufficient organizational and technical measures to protect the user's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties with it. However, we cannot guarantee 100% protection of personal data from illegal actions of third parties.

Modification

AffiliateIT has the right to change this Privacy Policy, change and modify the terms of access to or prohibit access to the site, as well as change its content at any time without prior notice.
